



MEDIA ACCREDITATION RULES

We kindly invite you to get acquainted with the Media accreditation rules of "RALLY ALŪKSNE 2020".

BASIC PRINCIPLES OF ACCREDITATION

Upon submitting the media representative accreditation application, media representative shall resolve duly and correctly inform the auditorium of the represented media about *"RALLY ALŪKSNE 2020"* before and after the event, as well as to correctly use the official title of the event: *"RALLY ALŪKSNE 2020"*

The media accreditation is envisaged for:

- journalists;
- media photographers;
- TV/video cameramen;
- representatives of competitors.

Only persons having reached the age of 18 will be accredited.

Accredited media representatives are STRICTLY FORBIDDEN to use drones or any other ground-controlled flying device if they don't have received permission by the organisers.

MEDIA TABARDS

Media representatives willing to receive accreditation, media tabard and be entitled to be present in dangerous areas of the track shall have **life insurance policy (including for motorsports competitions) with the value of at least EUR 1500.**

Media tabards for accredited media will be available for a guarantee fee of EUR 25.

The accredited media representative with the media tabard and card issued by the organiser of the event is entitled to be present in the especially envisaged media zones and no further than 1 (one) meter away of the security barrier (fence, stripe, other) of the dangerous areas of the track.

Accredited media representatives who hold a media card issued by the event organizer have the right to be behind the security barrier (fence, stripe, other) - right where the spectators are!

Handing over of the received media tabard or media card or tabard to another person is strictly prohibited.



SUBMISSION AND APPROVAL OF MEDIA ACCREDITATION APPLICATIONS

Form of Media accreditation must be filled out in official website of the event: <u>www.autorally.lv</u>.

Organiser will not assess Applications that are incomplete.

Granting and/or rejecting accreditation is fully in the hands of the Organiser. The Organiser reserves the sole right to distribute media tabards and cards to selected media.

Confirmation of the granting or rejection of accreditation to media representatives (to the e-mail indicated in the accreditation application) will be sent within 3 working days after receipt of the accreditation application.

ISSUE OF ACCREDITATION

Accredited media representatives will be able to receive and hand over media cards and media tabards at the media center. Media cards and media tabards can only be received personally by submitting a signed accreditation letter.
