

MEDIA ACCREDITATION RULES

Please acquaint yourself with media accreditation rules of rally “Kurzeme 2013” and fill in the media accreditation form accurately. Incorrectly or incompletely filled accreditation form may not be reviewed.

BASIC PRINCIPLES OF THE ACCREDITATION

By applying the accreditation application, journalist undertakes to inform audience of represented media about the event before, as well as after the event correctly and properly, and to correctly use the official title of the event: **Festival of Speed – Rally “Kurzeme 2013”**.

Accreditation is envisaged for:

- Journalists;
- Media photographers;
- Media video operators.

Accreditations are not envisaged for advertising or PR agencies, media representatives which are not journalists, photographers or video operators, as well as for representatives of the teams or supporters.

Team photographers will be accredited within the limits of possibility.

Only persons reached the age of 18 at the time of submitting of the accreditation form will get the accreditations.

SPECIAL RULES FOR THE PHOTOGRAPHERS AND VIDEO OPERATORS

Every photographer and video operator willing to get the accreditation must have:

- life insurance policy (incl. sports competitions) for the value of at least 1000 LVL or 1425 EUR
- media tabard issued by organizers of the rally “Kurzeme 2013”. Media tabards for accredited photographers and video operators will be available for guaranty fee of 20LVL or 30 EUR.

It is not allowed to pass issued media tabards to other persons.

Accredited photographers and video operators, having media tabards issued by the organizer, are allowed to be in the areas purposed for photographing and filming, but not closer then 1m from security bands.

APPLICATION SUBMISSION AND CONFIRMATION

Accreditation forms must be submitted until August 27, 2013 at 18:00. Organizer does not guaranty the confirmation of the application to the media representatives who will submit accreditation application after appointed term. Filling and submission of the accreditation form is available at www.rallykurzeme.lv.

Organizer will review submitted application forms within three (3) working days from the day of receipt. Confirmation or rejection of the application will be sent to the e-mail stated in the application.

Organizer singly decides about confirmation or rejection of the media application. Accreditations are assigned considering capacity of media centre and safe location of the media representatives in the rally areas. Number of accredited media representatives is not limited.

ISSUING OF ACCREDITATION AND MEDIA TABARD

It will be possible to receive and hand over accreditation cards and media tabards on August 29, 30 and 31 in the Media centre (Brīvības Street 39, Liepāja, Liepāja Olympic centre). Accreditation cards and media tabards can only be received in person.
